I – PERSONAL DATA - COOKIES

1) Personal data

During consultation of the <http://public.servicebox-parts.com> site, PEUGEOT is required to ask for certain user information, in order to identify and offer services to the user .

As regards information of a personal nature that the site user may be required to provide :

- the user is informed that by the application of the Data Protection and Civil Liberties Law in respect of Information Technology, files and modified liberties, the collection of personal information via the site is declared to the National Commission for Information Technology and Civil Liberties.
- the user is informed that by the application of Article 32 of the Data Protection and Civil Liberties Law of 6 January 1978, modified by the Law of 6 August 2004, the collection of this information enables subscription and the supply of the services offered on the site, to carry out invoicing, the follow up and management of these services and to enable commercial management of the site.
- the application of Article 40 of the Data Protection and Civil Liberties Law of 6 January 1978, modified by the Law of 6 August 2004, gives the user

- this information is for PEUGEOT, the companies within the PSA Group and the members of its Commercial network and may also be used within the framework of Commercial or Marketing operations, or as base data for studies and analysis.

2) Cookies

The user is informed that the site <http://public.servicebox-parts.com> has a system of cookies installed.

Cookies are files which are sent automatically to the users' hard drives in order to make it easier for them to browse the site and for compiling site-hit statistics. These cookies will never contain personal information.

The user can deactivate the sending of cookies by changing the parameters of his browser.

II – INTELLECTUAL PROPERTY RIGHTS

The site, in its entirety, is protected by French and International intellectual property rights legislation.

PEUGEOT notifies the users of the site that all elements of the site :

- are protected by Copyright law, such as photographs, articles, texts, drawings, animated footage, etc.;
